### REGULATIONS FOR EXHIBITORS

The LAUGHTON AUTUMN SHOW is open to all forms of steam driven or motor transport, farm machines, models and vintage cycles. Subject to stated entry limits and eligibility of the exhibit.

Date limits apply in the following classes:

**Cars**

A general date limit of 30 years old. Later cars may be accepted as representative of the marque, but those under 30 years will only be accepted if of exceptional historic interest and at the discretion of the organisers.

**Commercial Military, PSV and Tractors**

A general date limit of 30 years from the date of construction.

**Motor Cycles and Three Wheeler**

A general date limit of 25 years old – British built machines up to 25 years old may be included on a representative basis, subject to non-duplication and at the organisers discretion.

**LAND ROVER/RANGE ROVERS**

A general date limit of 25 years – This class is subject to non-duplication and at the organisers discretion.

**Classic Campers (no caravans)**

A fixed date of 40 years old and of historic interest.  
 CONDITION OF CLASS – This class will be at the organisers discretion. All campers must be fully restored and be placed in display (i.e. not in the campsite)

**Stationary Engines**

**This section please note:**

All entries will be checked carefully. All engines are to be of good interest to the public. We expect that the majority of the engines will be driving machinery of some type, also engines must be of the water-cooled variety. Other engines must meet a criteria of interest to the public.

**Models**

Should selection become necessary Preference will be given to accurate scale models of historic transport items.

**Scale Steam Vehicles**

No children (under 16) to be allowed to operate or drive without a responsible adult.

**Other Displays**

These will be accepted at the organisers discretion but displays featuring transport, historical or craft items, will receive preference.

**Car Clubs and Organisations**

Entries to this section will be given a designated area on the Showground depending on size of club. To be entered into section, organisers require that you appear for the duration of the Show (i.e. three day show – three days attendance).

**General**

It is a condition of our use of the showground that all DOGS must be kept on a lead at all times.  
 Camping space is limited to the exhibit's owner and immediate family and we cannot guarantee that will be available to all who require it.  
 All exhibits must be clean, tidy and of a high standard.

THE ORGANISING COMMITTEE RESERVE THE RIGHT OF REFUSAL OF ANY PERSON OR EXHIBIT.

- All exhibit's/vehicles etc must be in their allotted display areas by 10.00am and remain there until 5.00pm each day. No entry after 11.00am all show days. Commemorative Plaques will be available from administration from 5.00pm.
- The organisers would like to point out that the show closes on Sunday 7th Sept at 5.00pm and that all persons and exhibit's are requested to remain on station until that time.
- Persons leaving early will not be given preference at future shows.

### CONDITIONS OF ENTRY

**Closing date for all Exhibitor entries: 16th August 2025**

- 1 Exhibits must be presented in a clean and safe working condition.
- 2 All vehicles or working machines must be insured against third party risks whilst at the rally site. Please ensure that your policy covers off road and display usage. The organisers reserve the right to ask for proof of insurance.
- 3 Steam engines and exhibits with pressure boilers or vessels will only be admitted if owners can show proof of insurance and annual boiler inspection to the organisers.
- 4 Owners must ensure that all drivers of exhibits meet the requirements of the Road Traffic Act and conditions of the licensing Authority (no underage drivers) for the class of vehicle involved. No exhibit to be left running in the control of a person unable to stop or control it in an emergency.
- 5 No exhibit shall be left running unattended. All vehicles shall be safely parked securely braked and/or chocked.
- 6 No static exhibit with exposed moving parts below a height of six feet shall be operated other than behind a fence or rope provided as required by the organisers.
- 7 A speed limit of 5mph shall apply to all vehicles including modern support/site vehicles on the event showground.
- 8 No article whatsoever may be offered for sale in the exhibit display areas enclosures or tents without the written consent of the organiser.
- 9 All persons must pay proper regard to the steward's instructions and should conduct themselves in a manner which will not inconvenience other persons at the event.
- 10 ONE Exhibit Vehicle Pass is provided for each exhibitor which must be displayed clearly on vehicle for entry to show. The pass allows entry for one exhibit vehicle only containing maximum 2 people including exhibitor. Extra weekend passes may be purchased at the concessionary rate, adults: £20 and children: £10 (under 14).
